## MONTGOMERY GI BILL (CHAPTER 30)

*Educational Assistance Allowance for trainees under the Montgomery GI Bill - Active Duty (Ch. 30 of title 38 U.S.C.). For trainees on active duty, payment is limited to reimbursement of tuition and fees for the training taken.*

## RESERVE EDUCATIONAL ASSISTANCE PROGRAM (REAP/CHAPTER 1607)

*Educational Assistance Allowance for trainees under the Reserve Educational Assistance Program (Ch. 1607 of Title 10, U.S.C.). For trainees on active duty, payment is limited to reimbursement of tuition and fees for the training taken. Rates are proportionally reduced if less than 120 hours is worked.*
